Ethnographic Research

2016 – 2018: Collaborated with colleagues in Karachi, Pakistan, on how urban and rural poor, and women in particular, experience and challenge the effects of displacement caused by large infrastructural projects. The research spanned urban slum-dwellers, rural farming communities, and pastoralists, and focused on mining and road building projects in Punjab and Sindh provinces of Pakistan. This project was undertaken under the aegis of the Department of Social Sciences and Liberal Arts, Institute for Business Administration, University of Karachi.

2008 – 2014: Conducted research on "good governance" politics in contemporary India, with a particular focus on the pro-transparency and anticorruption mobilizations. My aim was to examine the growing trend of judicialized activism that privileges the law a mechanism for transforming governance and politics, more broadly, and to delve into the limits and potential of this strategy. I investigated the social lives and impact of two laws—one that passed (the Right to Information or RTI law) and one that failed to pass (Jan Lokpal Bill, an anticorruption law)—by focusing on the same group of activists as they shifted from promoting the first law to demanding the second. This group subsequently established a political party—the the Aam Aadmi Party or Common Man Party—with a populist promise to revolutionize governance; they fought and won the Delhi state elections, and are currently in power. I followed the entire political trajectory of these activists as they transformed from an NGO to a mass movement to a political party, and went from advocating transparency to fighting for a new anticorruption law to articulating a broader view of good governance. My ethnographic research included interviews, participant-observation, and volunteer work with the abovementioned group of activists, as well as state officials, citizens, civil society groups, NGO representatives, and academics. In addition, I conducted archival research on colonial state laws regarding governance (such as the Official Secrets Act). I also documented public cultural

and expert discourses about corruption, accountability, ideal democratic statehood and citizenship, and good governance, in India and on the global stage.

2004: Conducted participant observation of the 2004 World Social Forum (WSF) held at Mumbai, India. Seen as an activist answer to and critique of the World Economic Forum, the WSF brings together thousands of self-professed anti-globalization nongovernmental groups annually. I attended NGO workshops, speeches, and general forum activities, which gave me insight into the diversity of ideologies, agendas, and actors included under the general rubric of "the anti-globalization movement" and into the varied visions of India and the world in anti-capitalist imaginaries.

1998 – 2000: Conducted a multi-sited institutional and rural-level ethnography of the everyday practices of the *Mahila Samakhya* or MS program, a government-of India initiated rural women's empowerment program in India. This involved work and travel in the following Indian cities: New Delhi, Lucknow, Varanasi, Guwahati, Mumbai, Hyderabad, Jaipur, and Mussoorie. Conducted interviews with government officials, donors, MS staff members, feminists, development professionals, activists, and academics on gender, development, and state policy issues. Observed MS meetings at the national, state, and district levels, accompanied staff members on their daily field trips, and analyzed program documents for their approach to gender and empowerment issues. The rural component of the research examined the effects of the MS program on women's lives and identities and on gender relations in the north Indian state of Uttar Pradesh (with additional work in Andhra Pradesh, Gujarat, and Assam). This included participant observation in village-level program activities and other cultural celebrations, household socio-economic surveys, and semi-structured interviews with rural women (program participants and non-participants) and men, and local development administrators.

Summer 1997: Conducted a preliminary institutional and rural-level ethnography of the practices and effects of the Mahila Samakhya program in the western Indian state of Gujarat and in New Delhi.
